Re: Reid Residence Variance Request, 16 Forest Avenue, Chautauqua Institution

Dear John,

The owners of 16 Forest are requesting a variance to enclose a rear porch approximately four feet in width by six feet in length to accommodate a bathroom expansion on their second floor.

The proposed enclosure will encroach upon the required 3' side-yard setback (ALU Reg 4.4.6) and the addition will come within 6.7 feet from a wood deck below at 18 Forest and 11'-4" from the exterior wall of 18 Forest.

I have attached photos of the area that they are proposing to enclose as well as the neighboring structure. The existing house appears to be 10"-0" from the rear property line. The wood deck at 18 Forest is 9'-7" from the property line. The variance ,if approved would also require a variance thorugh Andrew Visdack for New York State Codes Div. as well and I have been in contact with Jeff Paddock regarding the potential variance.


HIGHLIGHTED AREA INDICATES AREA OF PROPOSED WORK
