## ARCHITECTURAL REVIEW BOARD MEETING NOTIFICATION

The owner of 36 Clark, Carol and Bob McKiernan, in the Neighborhood Traditional District, are coming before the Architectural Review Board with plans proposing an awning addition to the northern facing façade of their home above. This project's expansion proposes encroachments into the interior side yard, and the rear yard. Therefore, this project requires an Architectural Review Board review for the following considerations required for this scope of work.

Variances/Requests being considered:

1) Variance for a 4'-0" awning, extending from the Building, to cross the setback by 3'-4" on the Northern facade of the property at 36 Clark. (ALU Section 4.4.6)


